

Methodology and weighting convention

The American Disciplined Small Cap Index is a multi-factor smart beta strategy which provides an opportunity to invest in the stocks that comprise US small cap space. However, rather than weighting each stock based on the size of each company as measured by market capitalization, the strategy invests only in the top-rated stocks in each sector as determined by the firm's (Financial Trust Asset Management) proprietary ranking system. Financial Trust's ranking system compares companies in three areas – earnings momentum, quality, and valuation/price momentum. Sector weights are kept equal to the benchmark, while individual stocks are equally weighted within each sector.


